Business Agreement for Supplemental Internet DROS Submission Process

(Form B Rev.1)

Use of the WorldCom / DOJ DROS Entry System ("Service") constitutes agreement to the following terms and conditions. By using the Service, you assume full responsibility for all transaction charges incurred using the Internet DROS Submission Process and/or the Telephonic DROS Entry System. Entering into this Agreement shall in no way affect your relationship with your current telecommunications provider. The terms and conditions of the Service are subject to change upon prior notice to you. **Please mail this completed and signed form to:**

1. Should any unauthorized user obtain access to the Service, I will notify the MCI WorldCom DROS Service Center immediately at 1-800-974-3767. Notwithstanding such notification, MCI WorldCom shall not be liable for transaction charges fraudulently incurred on my account. It is my responsibility to pay these transaction charges.
2. I understand and agree that I am responsible for paying any DROS fees incurred when using the WorldCom / DOJ DROS service and to make such payments in accordance with the selected California Firearm Dealer Billing Option. If I do not give MCI WorldCom written notice of a dispute with respect to MCI WorldCom's charges within six (6) months of the invoice due date, such invoice shall be deemed correct and binding on me.
3. A service fee of \$20.00 will be added to my account for any dishonored check. When I receive notice of a dishonored check, I must pay the amount of the dishonored check and the service fee.
4. Any bill not paid by the invoice due date is considered late. If at any time MCI WorldCom has not received payment within forty (40) days from the invoice due date, I agree to be removed from the active DOJ Centralized Dealer List and will not be able to submit any further DROS transactions until my past due invoice(s) has been paid in full. To reestablish my DROS billing account with MCI WorldCom and to be reestablished on the DOJ Centralized Dealer List I agree to pay DOJ any associated service fees and to pay MCI WorldCom all outstanding invoices, current charges and any associated service fees and expenses imposed by MCI WorldCom in attempting to collect the balance due.

Additionally, I agree that if reestablished on the DOJ Centralized Dealer List, MCI WorldCom may cease to allow me to pay monthly in arrears for services received and (i) require that I prepay my account before any future DROS transactions are processed or (ii) place me in a "Pay As You Go" Status.

5. I understand that MCI WorldCom is not responsible for and will have no liability for hardware, software, information, or other items or any services provided by any persons other than MCI WorldCom. In no event shall either party be liable to the other or any third party, under any theory of liability, including but not limited to any contract or tort claim for any cause whatsoever, for any indirect, incidental, special or consequential damages, including loss of revenue or profits, even if aware of the possibility thereof.
6. Any dispute arising out of or related to this Agreement, which cannot be resolved by negotiation, shall be settled by binding arbitration by J.A.M.S./ENDISPUTE, an independent and neutral provider of arbitration services, under the J.A.M.S./ENDISPUTE rules.
7. I shall notify the MCI WorldCom DROS Service Center immediately upon any address or telephone number change associated with my account. Changes to my account can only be made by me.
